WILDLIFE REHABILITATION IS THE TREATMENT AND CARE OF INJURED, DISEASED, OR ORPHANED INDIGENOUS WILDLIFE, AND THE SUBSEQUENT RETURN OF HEALTHY VIABLE ANIMALS TO APPROPRIATE HABITATS IN THE WILD. THROUGH THE PROGRAM, OVER 10,000 PHONE CALLS ARE ANSWERED FROM PEOPLE ASKING FOR ADVICE OR HELP WITH WILDLIFE ISSUES AND ADMIT APPROXIMATELY 3,000 ANIMALS OF OVER 140 SPECIES ANNUALLY.
