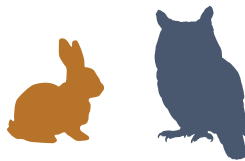


AN INVESTMENT IN WILDLIFE

HOW YOUR LEGACY, CAN SAVE WILDLIFE

BEQUEST

A bequest is a gift of personal property by will. If done by a will or trust while still living, a bequest reduces the amount of assets being included in federal estate tax calculations at the time of your death.

CHARITABLE LEAD TRUST

Donations may be made to WINC by transferring an asset into a trust. The trust provides income interest for a period of years or for the life or lives of an individual(s). The donor or a non-charitable beneficiary retains the remaining interest.



EDUCATE

We provide education programs to a variety of age groups to help build positive relationships between humans and native Wisconsin wildlife.

CHARITABLE REMAINDER TRUST

A charitable remainder trust is a popular tax-planning tool for individuals who want to make a future gift to WINC, while retaining the right to receive income from the asset.

CHARITABLE GIFT ANNUITY

Make a charitable gift when you wish, and receive a guaranteed life income at the date you specify. Deductible contributions are subject to statutory percentage limits.

We are a 501(c)(3) non-profit organization that does not receive federal, state or county funding. Our success depends on your generosity.

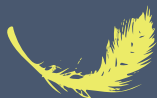


WINC IN YOUR WILL
